**A RESOLUTION AMENDING ARTICLE 7, SECTION 7-12, OF THE
RULES AND REGULATIONS**

WHEREAS, the Florissant Water and Sanitation District ("District"), provides water and wastewater services to customers located in Teller County, Colorado; and

WHEREAS, the operations of the District are administered by an elected five person Board of Directors; and

WHEREAS, pursuant to C.R.S. §32-1-1001(1)(j), the Board of Directors is empowered to establish and modify fees, charges, rates and tolls for water and sewer services.

NOW, THEREFORE, BE IT RESOLVED that effective immediately Article 7, Section 7-12, of the Rules and Regulations of the Florissant Water and Sanitation District is amended to read as follows:

Article 7, Section 7-12 Delinquency Charges; Collection Cost; Lien:

All charges for water and sewer services commence from and after the time a property owner taps the main lines of the District, unless contractual arrangements call for an earlier service fee payment time. All service charges shall be paid by the last day of the month. There will be a penalty if service charges are not paid by the last day of the month. In the event said payment is not made within thirty days following the last day of each month, water service will be terminated after ten (10) days written notice. In order to prevent a delinquent customer from continuing to use sewer services, the District shall have the option of disconnecting the customer's sewer service line from the District sewer main as well. The delinquent customer will be assessed all charges associated with the ten (10) day written notice of disconnection. Water and/or sewer services shall not be turned on again until all charges are paid, together with the cost to disconnect and reconnect services to the subject property. This includes the costs of excavation incurred by the District. During the period of time of said disconnection, customers are required to pay all service charges that continue to be levied against the subject property.

Until paid, all rates, tolls, fees, charges, interest, penalties, and cost of collection shall constitute a perpetual lien on or against the property served. Reference: Section 32-1-1001 (1)(j); and 32-1-1006 (1)(d).
